#### a. Update on Streetscape Capital Plan

- i. Menti-Meter results were very descriptive and helped us navigate specific words that our public thinks of us. We were able to see live responses, some as little as three words, others near a paragraph.
- ii. Draft plan is in the works but we do expect to have it next week. Once received we will be working with our partners at the Borough, Police Department and Fire Department to create a plan that is effective for all.

### b. Website Update and Branding Roll Out

 Website has officially gone live. There are a few tweaks that must be made (i.e. photos and titles of board members, moving events in the events section, etc.)

#### c. Public Art Update

- i. Artwork for the RWJ mural has been sent to print. We had to tweak the sizing of the mural as well as switch out our logo.
- ii. Proposal from Weingarten Art Group for the Giardinia Walkway. We expressed the need for a quick win, therefore we discussed finding a cheaper option and using the pergolas that exist there. Small option is \$20,000 (maintenance included). Need further discussion on the fabric and whether or not it is flame retardant.
