## A. Public Comments on the Budget

**Greg Storms** asked about the clean and safe contract and expressed that for the amount budgeted, he felt like we aren't getting the services contracted. He expressed that he has received complaints from businesses

and residents about the condition of the district.

Natalie reiterated that the clean and safe program is currently contracted out to a third-party vendor. She advised that the contract is up at the end of Feb. and that the DSA would be issuing a new RFP for services. She also advised that the DSA has reduced the budgeted amount for this service and is hopeful that the DSA will find a vendor that is more efficient and cost effective for the district.

**Ryan Storms** asked about the process by which a vendor is selected. Natale advised that one the proposal come in following the RFP, that the infrastructure committee will evaluate those, call for interviews and then mke a recommendation to the Board.

**Alvin Chingcuanco** from New Start Consignments questioned the lack of an AAPI Heritage Event in the event list for the year.

Natalie advised that most cultural events are partnerships with outside agencies and non-profits and informed the group that she would look into establishing such a partnership for 2024.

## **Comments from the Public**

John Vraniak from Osprey Lane Boutique questioned if there is a central information system where businesses can communicate with each other if there is a crime or emergency in the district.

Natalie advised that there currently is not but that the DSA can look into such a system.

In response, Vito Spadea from Somerville Police Department advised that it is not feasible to have a system solely for business owners to exchange information because, like social media, that inadvertently stops people from reporting crimes in a timely fashion.

He advised however, that the police department - through community police, is invested in figuring out a way to more efficiently get information out to the SID community and will work with the DSA to figure out a process that works for everyone.
